**1. ALL CONTESTANTS MUST BE OF AGE AS OF AUGUST 31, 2010  
AGES 14 - 15 - 16 - 17**

**2. DEADLINE DATES FOR APPLICATIONS AND ENTRANCE FEE OF \$75.00  
MUST BE IN HOUSE NO LATER THAN FEBRUARY 2, 2010**

**At this time you will learn the opening number and modeling patterns for the sportswear and poise part of the competition.**

**Each contestant must be prepared to perform her talent in full costume with props.**

**Each contestant must bring all outfits for approval. Please ask questions at this time, we will be happy to assist you.**

**5. TEEN CONTESTANTS WILL HAVE AN INTERVIEW ON SATURDAY FEBRUARY 27, 2010. (AT THE BUTLER COMMUNITY COLLEGE). TIME TO BE ANNOUNCED.**

**6. SCHEDULE FOR THE PAGEANT:**

**OUTSTANDING TEEN.....SATURDAY FEBRUARY 27, 2010.....7:00 P.M.**

**7. ALL TICKETS ARE RESERVED SEATING. FORM ENCLOSED.....TICKETS CAN BE PURCHASED AT THE MANDATORY DRESS REHEARSAL - BY MAIL - AT THE DOOR OR BY PHONE BY CALLING**

**8. OPENING NUMBER ATTIRE:**

**TEEN MISS..... TO BE ANNOUNCED**

**9. PHYSICAL FITNESS ATTIRE: An outfit you would wear to go to the gym or to a sporting event(NO PROPS)**

**10. TALENT:**

**ATTIRE.....All costuming must be age appropriate and coincide with the musical selection.**

**PROPS.....All props must be fully operational and meaningful to the talent presentation.**

**CDS.....You must have 2 high quality CD's with only your talent song on them. The talent song must be the only music on the CD so there is no confusion for the contestant or the tape technician. Each CD must have written on it: Name of Contestant - Number of Contestant - Name of Song.**

**TIME OF TALENT.....Talent must be a minimum of 1 minute. And not to exceed 2 minutes.**

**11. PLATFORM ISSUE.....The platform is an issue about which you have strong feelings which you want to communicate to others. This is the topic addressed in your Critical Issue Essay.**

**12. PHOTOS: 2 HIGH QUALITY PICTURES (COLORED HEAD SHOTS ONLY)**

**13. POISE AND APPEARANCE ATTIRE:**

**TEEN MISS.....T length or full length GOWN  
(ALL GOWNS MUST BE AGE APPROPRIATE)**

**14. ON STAGE QUESTION: DURING THE COMPETITION EACH CONTESTANT WILL BE ASKED 1 ON STAGE QUESTIONS.**

**15. TEEN MISS INTERVIEWS: EACH CONTESTANT WILL HAVE A SHORT INTERVIEW (7 minutes) WITH THE PANEL OF JUDGES. YOU WILL BE ASSIGNED A TIME AT DRESS REHEARSAL. THESE INTERVIEWS WILL BE HELD AT THE BUTLER COUNTY COMMUNITY COLLEGE. YOU SHOULD WEAR A CASUAL OUTFIT (NO SUIT) , APPROPRIATE FOR AN INTERVIEW.**

**16. ALL CONTESTANTS MUST BE OF GOOD MORAL CHARACTER, NOT USING FOUL LANGUAGE OR ENGAGING IN ANY ACTIVITY THAT IS NOT UPHOLDING THE STANDARDS OF MISS BUTLER COUNTY/MISS MORaine STATE.**

**17. ALL CONTESTANTS AND PARENTS MUST FOLLOW ALL DIRECTIONS FROM CHOREOGRAPHER, DIRECTORS, STAGE CREW, AND STAFF WITH RESPECT AND COURTESY.**

**18. IT IS EXPECTED OF ALL PARENTS TO HELP US SET A GOOD EXAMPLE FOR ALL THE CHILDREN OF THE PAGEANT. SHOW RESPECT TO ALL, DO NOT TALK NEGATIVELY ABOUT ANYONE, BE HELPFUL AND KIND TO EVERYONE. THANK YOU FOR YOUR HELP.**

19. THE TITLE WINNERS MUST PERFORM AT THE ESQUIRE PLAYERS CHRISTMAS SHOW - DECEMBER 2010 AND THE MISS BUTLER COUNTY/MISS MORAIN STATE PAGEANT IN 2010.
20. ALL CONTESTANTS WILL BE ALLOWED 1(ONE) CHAPERONE BACK STAGE TO HELP THEM DURING THE PAGEANT. (BADGES WILL BE PROVIDED AT DRESS REHEARSAL - ONLY PERSONAL WITH BADGES WILL BE PERMITTED BACK STAGE).
21. NO REFUND OF ENTRANCE FEE WILL BE PERMITTED.
22. ANY PARENT WHO OVERSTEP THE BOUNDS OF GOOD JUDGEMENT WILL NOT ONLY JEOPARDIZE THEIR CHILDREN PARTICIPATION IN THE PAGEANT BUT THE CONTESTANT WILL BE DISQUALIFIED.

MISS BUTLER COUNTY RESERVES THE RIGHT TO EXPEL FROM THE COMPETITION ANY ENTRANT WHO DOES NOT ABIDE BY THE RULES AND REGULATIONS AS STATED AND AS ANNOUNCED HEREAFTER.
